### Terms and Conditions Governing the Use of the NFTA Boat Harbor

The primary purpose of these terms and conditions is to safeguard life and property, and to insure the orderly operation of the NFTA Boat Harbor. Your adherence to these items and conditions will insure maximum enjoyment of the harbor facilities by all authorized boaters. The Boat Harbor operating season is May 15 to October 15. The NFTA is not responsible for operating season time loss due to weather, ice or storm damage conditions.

1. A copy of the current boat registration must be submitted with the contract application. All boats are expected to maintain proper insurance and an "all risk" insurance policy as may be necessary. The NFTA reserves the right to assign or re-assign slips in order to efficiently utilize all available slips. Subletting or transferring, directly or indirectly, is prohibited. Any and all rights and privileges granted by this permit are for the sole use of the Boat Owner.
2. Slip charges are to be based on overall boat length as follows: Maximum limit three feet over dock size. No part of the boat may extend past the limit. Personal watercraft, dinghies and other accessory equipment, cannot be longer than 10' and must be kept within the confines of the assigned slip. Charges may be adjusted and/or the boat may be reassigned to a larger slip if attachments like swim platforms are not accounted for on the contract.
3. Swimming, diving, fishing or bathing in the Marina is strictly prohibited.
4. Modification of Marina electrical equipment and docks is strictly prohibited. Cables connecting power post to boat shall be in good condition and of an approved type and suitable for Marina applications. Carpeting, tires, hoses, TV antennas etc. are not to be attached to the piers, catwalks or piles.
5. Slips shall be kept neat and orderly. All walkways must be kept clear at all times. Lines or cables should not lie across mains or fingers. No boat structures shall overhang or obstruct walkway.
6. All NFTA and applicable State and Federal laws, rules and regulations will be observed. When rules and regulations relating to public safety have been violated, the NFTA reserves the right to reject an application for a slip, and to terminate, without prior notice or refund, any permit issued.
7. Overboard discharge of any pollutant, trash, sewage, oil, diesel, gasoline, etc. is illegal. The Owner of the source vessel is liable for any such discharge and will be held responsible for clean-up costs and any applicable governmental fines incurred by the Marina.

8. Marina users shall respect the rights and privacy of others and maintain quiet hours from 10:00 pm to 7:00 am. Amplification of music or other sound is not permitted.
9. Children under 10 years shall be accompanied at all times by a parent or legal guardian.
10. Fire Prevention: refueling or bringing fuel to the docks is strictly prohibited. Observe rules and regulations at gas dock when pumping fuel. No open fires are permitted on boat or docks within the Marina. The only exception is for approved boat stoves or heaters permanently attached to the boat.
11. Pet owners must be able to show certified proof of their pet's current rabies inoculation for pets on board. All pets are to be on a 6-foot maximum lease at all times and are not to be left unattended.
12. Outside contractors or vendors performing commercial or business operations must obtain permission from the Marina manager to operate on the property. Certain fees, conditions, regulations and insurance requirements may apply.
13. The sole responsibility for boat maintenance and safety rests with the boat owner. All boats shall be properly secured to the docks and bow, stern and spring lines as necessary to provide a safe and secure connection to the dock. Lines shall be of a size suitable for the boat and shall be maintained in good condition. The Marina will assist boat owners when feasible. When necessary the Marina will call an outside contractor at the owners expense if the owner cannot be reached in case of damage mitigation measure.
14. The Owner assumes all risks related to this permit and shall be solely responsible and answerable in damages for all accidents or injuries to persons or property, and hereby covenants and agrees to indemnify and keep harmless the People of the State of New York; the NFTA; their officers and employees; from any and all claims suits, losses, damage or injury to person or property of any kind or nature, whether direct or indirect, arising out of the operation of this Permit, or the carelessness, negligence or improper conduct of the Owner or any servant, agent or employee thereof.
15. The NFTA shall not be responsible for theft, property damage and/or personal injury to the Owner, or any person upon the premises.
16. Any boat left in the Marina beyond the scheduled season closing date of October 15th, will be charged at a rate of \$1.00 per foot per day until the boat is removed.
17. The NFTA reserves the right, at any time, to amend terms and conditions, and/or to establish and implement further procedures to aid in the safe and orderly operation of the harbor and facilities.
